

## **CEA Director's Report**January 2017

#### **Miriam Swartz Benevolent Fund**

CEA raised a total of \$29,922.44 in 2016 – included was \$10,000.00 collected at the CEA conference; \$2500 from EASGV; \$1,000.00 from Eric Spitz, MyNHD; \$1,000.00 Avanti Notary; \$1,000.00 from Riverside Escrow Association; and \$400 from the website. The goal in 2017 is to reach a total of \$50,000.00 in funds available to members.

### **Membership Committee**

CEA ended the year in 2016 with 1088 members. This year's goal is to retain that number and increase by 1 for each region. The membership committee will be looking into "Dual Membership" to help create some type of uniformity in the way each region operates when it comes to the qualifications of a Director and report back to the board.

### **Professional Designation Committee**

The new Professional Designations Workbook is now complete! Members may purchase the workbook online for \$75 on the CEA website. A link will then be sent with the online workbook, which will be made available to download within 10 days. The Committee is continuing to work on Online Testing, which may not be available until 2018. For now, there are 3 PD test dates scheduled: EASGV on April 29, 2017, NorCal in July in San Ramon and at the CEA Conference in Costa Mesa in October (either 10/11 or 10/15). Practice Test are currently being worked on and PD Test are being reviewed for current relevance, wording and how points are being calculated to increase the passing rate.

## **CEA Director's Report**January 2017

#### **Bill Review:**

The California legislature is on its way to the new two (2) year cycle for 2017-2018. Swearing in of new members occurred in December. The Legislature formally opened its doors on January 4 th . The deadline for new bills was January 20th. By February 17th , all new bills must be introduced and identified with a sponsor. The bills will be reviewed and identified by the end of March- and just in time for our April meeting.

The pulse in Sacramento is tense. The California vote spoke boldly in the November elections with decisive vote for the Democratic Party. Anticipate and expect the year will be volatile. On the State level, it is possible that sales tax on services may resurrect itself. Immigration, climate change, consumer issues and health care are other hot topics.

Stay tuned.

### **Escrow Practices:**

This year the committee is expected to review matters regarding Information security, regulatory matters and complaint enforcements, technical transparency and the effects and demands of the primary and secondary money markets on escrow desk. Conference Calls for this committee begin in mid-February, and are scheduled monthly.

#### **Governance:**

This is an on-going project to bring the Policies and Procedure Manual current. Good progress was made last year, and the committee conference call resume on February 16 th . We will keep you apprised.

#### **Awards**

Our own Vanessa James was awarded committee chair of the year and Mickey Vandenberg was awarded the Olga Mitchell rookie of the year award.

### **Professional Designation**

- **TEST MODERNIZATION:** There was an impressive presentation by the PD committee on the research the team has done to take the tests online. CEA is working with online education software company Proprofs on this ambitious project. Procedures are being established to address test cancellations to have a plan in place in the event an association that is unable to facilitate a scheduled exam as with what occurred in the LA region this year.
- **PD HOLDERS CONTINUING EDUCATION:** A motion was passed to allow 2 vendors, <u>The Business of Escrow</u> and <u>The Escrow Training Institute</u> to give continuing education credits for certain classes.

#### C.A.R.

For the first year ever, CEA exhibited at the annual California Association of Realtor Conference. A committee has been formed to participate in future CAR contract updates.

### Legislative Bill Review

AB 1779 - Revocable Transfer on Death Deed

AB 1974 – Re-recording of documents will now require re-notarization and re-acknowledgement by notary.

AB 2217- Notary fee increases to \$15 per signature.

AB 2566- Notaries are now allowed to accept Matricular Consular cards and valid passports without the visa stamp.

AB 2693- New disclosure requirements for PACE loans to buyers in a resale transaction.

AB 2416- CEA sponsored- 5-year Renewal requirement of vetting companies (such as SSI) to be treated as credit reporting agencies in California.

### Notary Update- carried over from April 8, 2016 "content and cocktail" session

- Individual line item listing for EACH document notarized is a requirement however the Secretary of State's office communicated that they will not fine notaries as long as each document notarized is described on the line.
- Corrections: Secretary of state does not allow the acknowledgement or Jurat to be changed after the consumer has left the presence of the notary. Revocation of commission can result if discovered.



### The §1031 Tax Code is in Jeopardy

In June, 2016, House Ways & Means Committee Chairman Kevin Brady (R-TX) and his predecessor, Speaker Paul Ryan (R-WI) announced the "Blueprint for Tax Reform," an ambitious plan for radical simplification and a complete rewrite of the tax code. The authors believe that the Blueprint will achieve three distinct goals:

- Create jobs and economic growth
- Make the tax code simpler, fairer and less burdensome
- Transform the IRS into a kinder, gentler, taxpayer focused agency.

The path to achieving massive simplification and rate reductions appears to be the elimination of most deductions and exclusions in favor of larger standard and personal exemptions.

Businesses would be permitted to claim an immediate expense deduction of 100% of the cost of newly acquired assets. Unlimited net operating losses could be carried forward indefinitely. The Blueprint is silent as to 1031 exchanges. There is concern that the tax writers may assume that with lowered rates and full expensing, exchanges would be unnecessary.

Recent studies have shown that without a tax-deferred mechanism, a lock-in effect occurs. The immediate recognition of a gain upon the disposition of property would impair cash flow and could make it uneconomical to replace that asset. If investors are faced with reducing the value of their investments through capital gains or recapture tax, even with lower tax rates, they will likely hold onto these properties longer. Section 1031 removes the lock-in effect and permits taxpayers to make good business decisions

without being impeded by negative tax consequences.

A broad coalition of organizations, including the REALTORS and the Federation of Exchange Accommodators are working to make our policymakers aware that exchanges need to remain in the tax code. Exchanges stimulate economic activity in the United States, and generate jobs. Recent economic studies have quantified that either eliminating or restricting like-kind exchanges would increase the cost of capital, slow the rate of investment, lower property values and reduce transactional activity resulting in economic contraction of up to \$13.1 billion annually.

## Which Tax Scams Should I Be On The Lookout For This Tax Season?

As tax season approaches, taxpayers are reminded to be on the lookout for an array of evolving tax scams related to identity theft and refund fraud. Every year scam artists look for new ways to trick taxpayers out of their hard-earned money, sensitive financial information or even access to their computers. Here's what you need to know this year:

Requesting fake tax payments: The IRS has seen automated calls where scammers leave urgent callback requests telling taxpayers to call back to settle their "tax bill." These fake calls generally claim to be the last warning before legal action is taken. Taxpayers may also receive live calls from IRS impersonators. They may demand payments on prepaid debit cards, iTunes and other gift cards or wire transfer. The IRS reminds taxpayers that any request to settle a tax bill using any of these payment methods is a clear indication of a scam.

Targeting students and parents and demanding payment for a fake "Federal Student Tax": Telephone scammers are targeting students and parents demanding payments for fictitious taxes, such as the "Federal Student Tax." If the person does not comply, the scammer becomes aggressive and threatens to report the student to the police to be arrested.

Sending a fraudulent IRS bill for tax year 2015 related to the Affordable Care Act: The IRS has received numerous reports around the country of scammers sending a fraudulent version of CP2000 notices for tax year 2015. Generally, the scam involves an email or letter that includes the fake CP2000. The fraudulent notice includes a payment request that taxpayers mail a check made out to "I.R.S." to the "Austin Processing Center" at a Post Office Box address.

Soliciting W-2 information from payroll and human resources professionals: Payroll and human resources professionals should be aware of phishing email schemes that pretend to be from company executives and request

personal information on employees. The email contains the actual name of the company chief executive officer. In this scam, the "CEO" sends an email to a company payroll office employee and requests a list of employees and financial and personal information including Social Security numbers (SSN).

Imitating software providers to trick tax professionals: Tax professionals may receive emails pretending to be from tax software companies. The email scheme requests the recipient to download and install an important software update via a link included in the email. Upon completion, tax professionals believe they have downloaded a software update when in fact they have loaded a program designed to track the tax professional's keystrokes, which is a common tactic used by cyber thieves to steal login information, passwords and other sensitive data.

"Verifying" tax return information over the phone: Scam artists call saying they have your tax return, and they just need to verify a few details to process your return. The scam tries to get you to give up personal information such as a Social Security number (SSN) or personal financial information, including bank numbers or credit cards.

Pretending to be from the tax preparation industry: The emails are designed to trick taxpayers into thinking these are official communications from the IRS or others in the tax industry, including tax software companies. The phishing schemes can ask taxpayers about a wide range of topics. E-mails or text messages can seek information related to refunds, filing status, confirming personal information, ordering transcripts and verifying PIN information.
